**ANTIOCH CHRISTIAN ACADEMY PROVIDES EDUCATION TO 240 STUDENTS IN 2024. IT CURRENTLY OFFERS KINDERGARTEN THROUGH HIGH SCHOOL. PARENTS CHOOSE THE SCHOOL BECAUSE IT OFFERS QUALITY EDUCATION, INCLUDING ENGLISH PROFICIENCY CLASSES, A BIBLICAL WORLD VIEW, A SAFE AND FRIENDLY ENVIRONMENT, AND A CURRICULUM FOCUSED ON DEVELOPING CRITICAL THINKING AND PROBLEM SOLVING. IN A REGION WHERE ONLY 23% OF CHILDREN ATTEND HIGH SCHOOL AND 1% ARE ABLE TO REACH COLLEGE LEVEL EDUCATION, THE SCHOOL STANDS AS A PLACE TO EMPOWER CHILDREN THROUGH EDUCATION SO THAT THEY MAY BREAK THE CYCLE OF POVERTY AND ABUSE. IN 2023, A BASKETBALL CLUB WAS CREATED THAT PROVIDED TRAINING TO 100 KIDS. THE PROGRAM FUNCTIONS DURING WEEKDAYS FOR 10 MONTHS DURING THE YEAR.**

**THE STUDENT RESIDENT HOME PROVIDES A SAFE AND HOME-LIKE PLACE FOR GIRLS WHO ATTEND ANTIOCH CHRISTIAN ACADEMY BUT ARE UNABLE TO COMMUTE FROM AND TO SCHOOL ON A DAILY BASIS. IN 2024, 8 GIRLS RECIEVED FOOD, SHELTER, AND MEDICAL CARE, TUTORING, COUNSELING AND TRANSPORTATION TO AND FROM THEIR HOME. IN 2024 THE RESIDENCE HOSTED 8 GIRLS. PARENTS SEND THEIR DAUGHTERS TO THE RESIDENT HOME BECAUSE ACCESS TO DEVELOPED EDUCATION IN THE DEEP JUNGLE IS NOT POSSIBLE.
